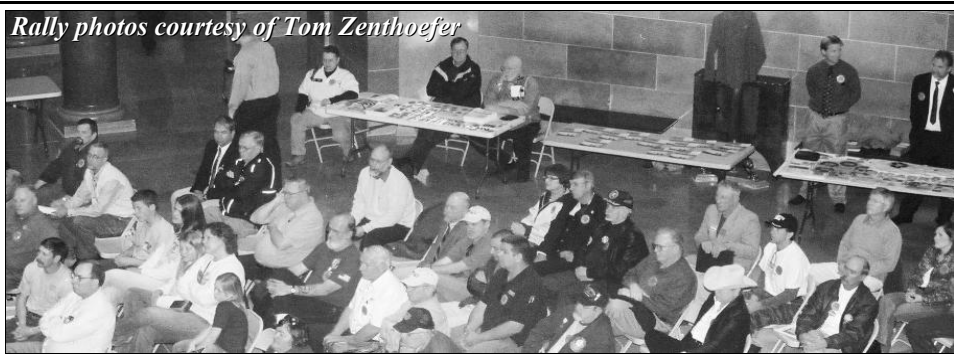

# The President's Podium

## RALLY FOR RANGES

The rifle I hold in the accompanying picture is a Belgian Mauser which sports a Czech bayonet. It was probably captured and spent WW II enforcing the edicts of the Third Reich. At some point, it was purchased by, stolen by, captured by, or donated to a Zionist group and some time later converted both to Israeli ownership and 7.62 caliber; now it is mine. The rifle symbolizes the many aspects and history of the shooting sports. We have many and varied types of guns, many and varied models of each type, and many and varied sports for each model and type. We all come together in one shooting organization.

A couple of Board members have apologized for missing the last Board Meeting; however, they missed it because they were running shooting competitions. They have no need to apologize. We have Board Meetings to support shooting events, not the other way around. The Board Members have taken time, talent, effort, and gas money to support all the shooting sports, and I am proud to be among them.

The Fifteenth Annual Gun Rights Rally was held on 29 April, 2008 in the Rotunda of the Capital Building in Jefferson City. This Rally is put on by Missourians for Personal Safety (MPS). This group is an umbrella organization for grassroots gun rights organizations composed of the Missouri Sport Shooting Association, the Western Missouri Shooters Alliance in Kansas City, the Gateway Civil Liberties Alliance in St. Louis, and MissouriCarry.com. MissouriCarry, GCLA, and WMSA are also affiliates of MSSA. The theme of the rally was changed two weeks before the event from the U.S. Supreme Court case on the Second Amendment to saving our shooting ranges. Recently, a Boone County jury returned a judgment against Cedar Creek Rod and Gun Club in the amount of \$700,000. The club had not killed anyone; the complaint was over the noise from trap and skeet shooting. The court then issued an injunction which virtually shuts down the range. Many of the claims were scientifically impossible, but the jury believed them. Another range has been harassed with false claims of lead contamination. Lead, it seems, is perfectly all right in the ground where God put it, but if dug out, molded into bullets and shot back into the ground, it is toxic. The club overcame the accusation, only to be accused of shooting into a structure outside of the range. Three different bullet holes, made on at least two different occasions, were found. Investigation proved that the shots did not come from the range. This raises the suspicion that someone is trying to shut down the range and made complaints and fired the shots in that effort.

Many, if not most, of my brothers and sisters in the Bar are in the profession only to make money. The rest of us have to make money. The huge judgment against Cedar Creek has the effect of making gun clubs look like ATM machines to lawyers. The Rally was an attempt to push the Range Protection bill through the Senate.

By head count, 230 shooters braved gasoline prices to support our rights. After some rousing speeches, they were unleashed on the Senate. As of this writing, there is some evidence of success.

Speaking of success. The National Park Service is accepting comments on a proposed rule that would allow carrying concealed weapons in National Parks. This has obvious self-defense benefits. In addition, our members have camped in or taken RV's to National Parks. This proposed rule would make it easier for our members who travel to competitions, travel for pleasure, or simply travel when their route lies through a National Park.

# 15th Annual Capitol GUN RIGHTS RALLY

*It was just 2 weeks before Rally Day when new Rally flyers began circulating that called for a strong turnout to help save our firing ranges. The call-out was heard! On the morning of Rally Day – 10 a.m. Tuesday, April 29th – the Capitol Rotunda was filled with Missourians who came to support passage of the “Range Protection Act.”*

Harold Miederhoff, Lee Koester, and I were early and set up on one of the tables lining each side of the Rotunda. We began greeting people as they came by, handing out MSSA brochures and copies of *The Missouri Shooter*, and engaging in shop talk. Members of the Gateway Civil Liberties Alliance (GLCA), the Western Missouri Shooters Alliance (WMSA), and MissouriCarry.com were doing the same.



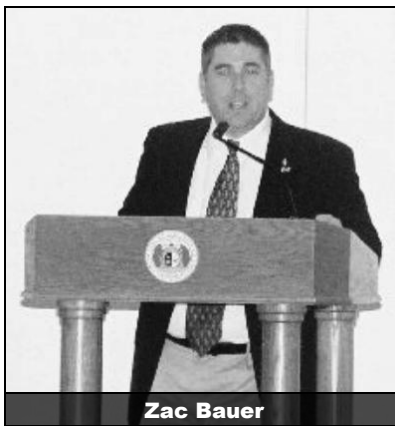
I left to walk the circuit, stopping briefly to admire the banner frame over GLCA's table. Mental note: Do one for MSSA. (Lacking any place to hang it, our banner was laid out like a tablecloth.) I turned and went on, a glad-run into familiar faces.

For activists, a Rally is a reunion of friends from all across the state; but I was just as glad (and relieved) to see a large number of unfamiliar faces in the crowd. Regular gun owners, not just gun-rights activists, had driven to the State Capitol to join us and help stop the threat against shooting ranges. It was a good sign that positive things would be accomplished.

Folks began taking their seats among the numerous folding chairs fanned out before the “stage” of the Rotunda. I took mine and waited. By 10 o'clock, people were left standing on both sides and in the rear. An excellent turnout for a working day, and on short notice, too – a *really* good sign.

## The Rally Kicks Off!

Zac Bauer (MSSA Board Member; Founder and Board Member of MissouriCarry.com) was the first to take the podium. He gives us a hearty welcome, and then leads the Pledge of Allegiance. As the Master of Ceremonies, Zac will be introducing each speaker as the Rally progresses.

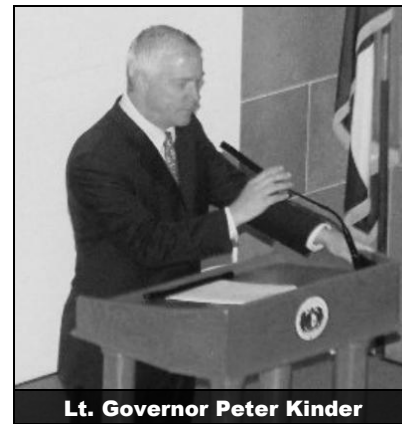

## The Speakers

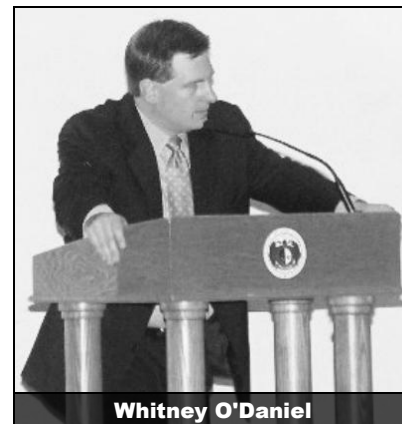

**Asst. Attorney General Peter Lyskowski**, our "Firearms Law Go-To Guy" in the AG's Office, came to the Rally and spoke to us about Missouri ccw permit reciprocity with other states – and also announced that the State of Washington had just come on board! (As of this writing, thirty-five states have reciprocity agreements to honor Missouri's ccw permit; *no other state's ccw permit is honored by so many.* KUDOS to Peter 'et al' in the AG's office!)

The last two Rally speakers were **Kevin Jamison** and **Tim Oliver** (*MSSA Director and Vice-President of MissouriCarry.com*).

**Kevin** provided the Overview, speaking to the purpose of the Rally: He told why there was a desperate need for range preservation in Missouri and related a number of stories about ranges that have been sued or are now being harassed.

**Tim** would deliver the Key Note address: a detailed history of the "Battle to Save Cedar Creek." He introduced everyone to Ralph and Mary Ann Gates, the managers

of the Cedar Creek Rod and Gun Club, who rose for a moment upon the intro...

*I knew the story, but still it shocks me. The Cedar Creek range was the latest to fall victim to a "noise nuisance" lawsuit, and the outcome was bad – to the tune of SEVEN HUNDRED GRAND (\$700,000), plus severely-limited hours of operation. The exorbitant verdict was enough to make trial lawyers drool at the sound of a gunshot – or, as Kevin says, start viewing ranges as ATM machines. The threat level against firing ranges everywhere had risen dramatically. Getting a good range protection law this year was top priority.*

Tim ended his presentation, issued us our "walking orders," and the Rally was over. And then, the Capitol halls were echoing – with the sounds of motivated citizens enroute to their legislators' offices.

*After the Rally, HB2034 began to gain strength and momentum, until the Range Protection Act finally passed, at 11:06 p.m. on May 15, 2008, the next to the last day of the session. To Everyone - Well done!*

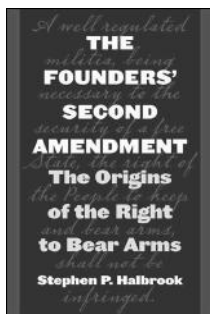

## THE FOUNDERS' SECOND AMENDMENT Origins of the Right to Bear Arms

During the oral arguments in *District of Columbia v Heller*, the Supreme Court justices questioned the lawyers on the origin and scope of the Second Amendment as it was understood at the time it was written. They could have saved their voices, if they wanted to, by reading this book.

The author is a well-known author and attorney on Second Amendment issues. He supplied one of the amicus briefs to the Supreme Court in *Heller*. There need be no fear that this is a recycled brief. Mr. Halbrook's books are exhaustively researched, perfectly organized, and well written. This effort recounts the many different efforts of the British government to disarm individual colonists. These efforts triggered outrage in the population resulting in the Battles of Lexington and Concord. From this historical background and the British common law came a cultural belief in a pre-existing and natural right to keep and bear arms. The evolution of this cultural belief into the Second Amendment is carefully presented in these pages.

The debates over the Second Amendment itself are presented as are similar provisions in state constitutions of the time. The state debates over ratification of the Bill of Rights are presented as they relate to the Second Amendment. In all venues, the right to keep and bear arms is accepted as a given, the only dispute was how to express this right so that it could not be abused.

While vast sections of period documents are quoted in the text, the author clearly explains the context and meaning of the sources. The result is an authoritative yet easily understood explanation of the Founders' intent regarding the Second Amendment.

# CHAMPIONSHIP RESULTS

## MISSOURI JUNIOR SHOOTERS COMPETE IN The National Junior Olympic Championships

Six Missouri junior shooters competed at the USA SHOOTING National Junior Olympic Championship held at Colorado Springs, Colorado. Approximately 300 top junior rifle and pistol shooters from around the U.S. traveled to the Olympic Training Center in Colorado Springs on April 4-19, 2008 to compete for National Junior Olympic Titles. Competition for the Rifle/Pistol National Junior Olympic Championships began with the rifle events and concluded with the pistol competition.

To participate in the National Junior Olympic Championships, athletes had to shoot in their State Junior Olympic Championships and either win the match or shoot above a certain score to be

invited to the competition. Athletes who are invited have the opportunity to stay at the Olympic Training Center and get a glimpse of what it's like for full-time resident athletes, living and training for the Olympic Games.

The Juniors are competing according to their age. There are several different age groups for young shooters (based on athlete age in 2008):

**Junior 1 (J1):** Ages 18-20, competitors born 1988-1990.

**Junior 2 (J2):** Ages 15-17, competitors born 1991-1993.

**Junior 3 (J3):** Ages 14 or younger, born 1994 or later.

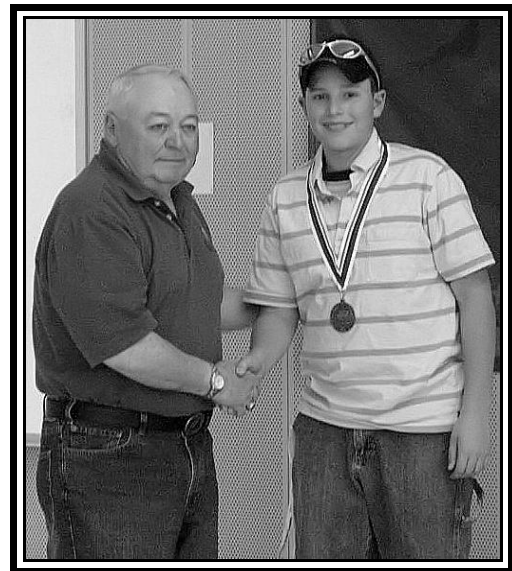
All are to be congratulated on their performance. They shot well.

### Garrett Spurgeon (J3) Places Third at the National Junior Olympic Championship

MSSA Junior Member Garrett Spurgeon placed third nationally as a (J3) in Men's 50-meter 3-Position Smallbore Rifle and 50-meter Prone Smallbore Rifle. His 3-Position score was 2154, and his Prone score was 1144. The photo at right shows Garrett receiving his award and being congratulated by Lones Wigger, a two-time gold medalist in the Olympics who will be inducted into the U.S. Olympic Hall of Fame June 19, 2008.

Garrett was the youngest member of the MSSA Junior Rifle Team that traveled to Martin, Tennessee and Murray, Kentucky. Garrett has also attended the MSSA Junior Rifle Camp for the past several years.

# MISSOURI JUNIOR HIGH-POWER RIFLE TEAM

*We're looking for a few good kids!*

As you know, the Missouri Sport Shooting Association does a great deal to support the shooting sports within the state of Missouri. We provide support for local clubs and organizations, monitor all sanctioned state championships, and of course, the Association does all it can to support Missouri's youth and keep them involved in the shooting sports. I'd like to tell you a little more about one of our programs that might inspire you or a young person you know to become involved in NRA high power rifle matches. Please forgive the vagueness of this article, but I simply can't put everything about the sport or our program in one article! Feel free to call or email with any questions.

NRA high power is shot with center-fire rifles from the standing, sitting, and prone positions. The course of fire typically begins at 200 yards and ends with shooters firing from 600 yards away. There are two classes of rifles used, service rifle and match rifle. Service rifles must be an M1 Garand, M-14, M-16, or the civilian equivalent of those rifles. Modifications to these rifles are heavily restricted in an attempt to keep a level playing field. Match rifles are heavily modified bolt action or semi-automatic rifles, with very few restrictions. Iron sights are used most often, but scopes are allowed for some matches shot at longer distances. The sport has a long history and has been the sport of choice for some of the nation's finest riflemen. Matches are held at the

local, state, regional, and national level. The pinnacle of the shooting season is the National Matches at Camp Perry, Ohio, where for over 100 years, America's top shooters have congregated to socialize and shoot for the title of National Champion. Both of these organizations sponsor rifle competitions and can provide you with lots of useful information about the sport.

One of the longest traditions in High Power is that of junior shooting teams. Shooting has always been instilled in the lives of America's youth, and allowing them to compete provides a means for them to hone their skills and mature as they become students of the sport. I myself was a junior shooter growing up, and I cannot begin to describe what a difference it has made in my life. I know that I wouldn't be the person I am today without the experiences I had and the lessons I learned as a member of a junior team. Competitive shooting allows young people to learn about themselves and explore their competitive nature. They will learn firsthand what results practice and dedication can bring. The lessons learned on the firing line will make them a better shooter and better prepare them for life in general.

The Missouri Sport Shooting Association is doing its part to continue this tradition. We provide support for junior shooters in our state; and, right now, we are currently looking for new members to fill out our team. Support comes in the form of reloading components for the shooters (bullets, powder, and primers), and we do have some rifles that can be assigned to shooters to use. Support is provided only after the shooter becomes involved and is an active participant, shows a desire to continue in the sport, and has met a few requirements that we have for team members. We are looking for young men and women who have a love of the shooting sports and have a desire to prove themselves in competition. These shooters will represent their state in matches, here in the Midwest and at the national level at Camp Perry. Our goal is to provide the young men and women of Missouri the opportunity to shoot competitively and enjoy the camaraderie of fellow shooters.

If you are a youth shooter or know of a young man or woman who might be interested in competitive high power shooting, please contact me at your convenience so that we can discuss the team a little more. If you happen to be an adult and are interested in high power shooting, call me anyway, and we'll talk about the sport and get you started! Hopefully, this article will result in some new shooters, both young and old.

## OZARK HIGH Wins National Championship

Over Spring Break, the Ozark High School JROTC Rifle Team, along with the nation's best high school JROTC rifle teams, competed in the National JROTC Air Rifle Championship at Fort Benning, Georgia.

The shooters in this championship qualified through a series of matches that started with 6,000 competitors from over 1,100 schools. Only the best of these are allowed to compete at Fort Benning. The Ozark High School team – consisting of Shawn Spradling, Kelsea Hunt, Rob Thompson, Jacob Edwards, and alternate Alan Snyder – won the National Championship, beating the second place team by over 30 points.

The competition consisted of two days of shooting, and our team was down by 6 points going into day two. Our team finished the competition very strong and set a competition record with their score of 4331.

Individual honors went to Shawn Spradling, for placing 2nd overall for all the services, and Kelsea Hunt, for winning the Army individual Army National Championship.

The team is coached by 1st Sgt. Terry Thompson.



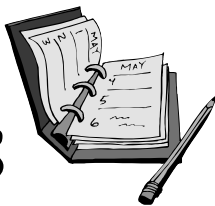

## NRA National Action Pistol Championship Celebrates 30th Annual Competition

FAIRFAX, VIRGINIA – For the past 30 years, the National Rifle Association has celebrated action pistol as one of the premier disciplines in shooting sports. Its masterpiece, the NRA National Action Pistol Championship, also known as the NRA Bianchi Cup, will crown another superstar this year in Columbia, Missouri, May 21 to 24. Year after year the NRA Bianchi Cup brings more than 200 of the world's top pistol marksmen to the Green Valley Rifle and Pistol Club's Chapman Academy Range. The sizeable cash and prizes awarded to the winners ranks this tournament one of the richest in the sport.

"The NRA Bianchi Cup showcases the top pistol marksmen in the world," said John C. Sigler, President of the NRA. "NRA competitive shooting programs and events play an important role in NRA's overall success in providing law-abiding Americans with a variety of exciting and demanding opportunities to exercise their Second Amendment rights in a safe and secure venue. Championships like this demonstrate the importance of securing the world of competitive shooting for generations to come."

Since its inception, the NRA Bianchi Cup has retained its original course of fire, consisting of four matches: Practical, Barricade, Moving Target and Falling Plates. Speed and accuracy is the key to

winning the Championship. Each event is timed and is worth 480 points, equaling a total of 1920 possible points.

Action pistol competitors are permitted to use a two handed grip, and competitors must start with their guns holstered. During the course of the matches, participants fire at turning cardboard silhouette targets, moving targets, and steel plates that must be knocked down to count as a hit. This type of competition makes the match more appealing to spectators.

The defending champion, Doug Koenig of Alburts, PA, will return once again. In 2007 he won his tenth NRA Bianchi Cup — but his first since 2005. Bruce Piatt, Carl Bernosky, Rob Leatham and countless others are expected to return for this historical year.

An invitation match called the Bianchi International Speed Event concludes the tournament. The top-scoring competitors from the open championship join the top-scoring four women, junior and senior competitors in an elimination contest which measures the contestants' accuracy and speed. This year's competition will also include the first-ever Ray Chapman Speed Star Event, a tribute to one of the competition's designers.

## Father Martin Hagan

1919 - 2008

Father Martin Hagan SJ, long time supporter of Shooting Sports for Juniors, died peacefully on Monday morning, April 28, 2008, at Saint Louis University Hospital in St. Louis, Missouri. Father Hagan was 89 years old and a member of Jesuit Hall Community. He was born in Wichita, Kansas on March 11, 1919 and entered the Society of Jesus at St. Stanislaus Seminary in Florissant, Missouri on September 1, 1937. He was ordained June 14, 1940 in St. Mary's College in Kansas. He was assigned to St. Louis University High School where he spent the next 51 years teaching and counseling freshmen.

Father Hagan founded the school rifle club which he coached to five national championships. The rifle club currently competes very successfully in International Air Rifle and 3 Position Air Rifle. He also held the Missouri State Junior Olympic Championship Matches for Smallbore Rifle, Air Rifle, Smallbore Pistol, and Air Pistol.

Father Hagan was well known and respected by all who knew him and will be missed by all of us involved with competitive shooting.

Legislative Update by Mona Oliver

## 2008 MO Firearms-Related Legislation

This year's legislative session ended May 16 – and was another great year for the pro-gun-rights community! No anti-gun bills passed, and our legislative goal for a good range protection law was accomplished. Range protection was *overwhelmingly* passed with **House Bill 2034**, which includes other important legislation from bills rolled in with House/Senate Committee Substitutes. HB2034 now awaits the Governor's signature. As law, it will go into effect August 28, 2008. Below is the official **Bill Summary**, plus some added emphasis (bold, underline, italics) and added comments (in brackets). The full text of the final bill is here:

### SCS HCS HB 2034 -- WEAPONS

This bill changes the laws regarding weapons. In its main provisions, the bill:

1. Expands the criminal liability immunity for owners of firearm ranges to include authorized users of the ranges and immunity from any civil liability for actions arising out of the use of the firearm range [ **see bracketed comments in #2** ];
2. Specifies that all owners and authorized users of existing hunting preserves or areas that are designated as hunting preserves [ **and FIREARMS RANGES** ] will be immune from any criminal and civil liability arising out of or as a consequence of noise or sound emission resulting from the normal use of the hunting preserve and the preserves will not be subject to an action for public or private nuisance or trespass. [ **Can't sue for range noise, 1000-yd adjacent-property-limit gone; also NULL & VOIDS related PAST judgments against ranges!** ] [ **CAN sue:** ] No firearm range or hunting preserve will be immune from civil liability for compensatory damage arising from physical injury to another person, tangible physical property, or fixtures or structures placed on real property;
3. Specifies that a landowner who invites or allows any person to use the property for recreational purposes without charge confers upon the person the legal status of trespasser and [ **the landowner** ] does not assume responsibility for or incur liability for any injury to any person or property caused by an act or omission of the person while engaged in recreational activities without the failure to exercise just ordinary care [ **e.g., invited hunter can't sue landowner for falling out of tree** ];
4. Defines "blasting agent" and "detonator" as they relate to an offense regarding weapons [ **technical addition to statutes** ];
5. Creates the crime of unlawful refusal to transfer a firearm when a person denies the sale of a firearm to a non-licensee solely on the basis that the non-licensee purchased a firearm that was later the subject of a trace request by law enforcement. Anyone violating this provision will be guilty of a class A misdemeanor [ **trace not a reason to deny gun sale; must sell** ];

6. Specifies that no firearm silencer may be possessed, manufactured, transported, repaired, or sold as a curio, ornament, or keepsake unless the seller is an importer, manufacturer, dealer, or collector licensed by federal law;
7. Specifies that a person may be guilty of unlawful possession of a firearm if he or she knowingly has any firearm in his or her possession and has previously been convicted of a felony in this state or a crime in any other state that would be a felony in this state [ **aligns Missouri law with federal law** ];
8. Creates the crime of unlawful possession of an explosive weapon when a person possesses any explosive weapon and has pled guilty to or has been convicted of a dangerous felony, has attempted to commit a dangerous felony, has committed a crime in any other state which would be a dangerous felony in this state, has been imprisoned in this state or elsewhere during the five-year period immediately preceding the date of the possession, is a fugitive from justice, is habitually in an intoxicated or drugged condition, or is currently adjudged mentally incompetent. Anyone violating this provision will be guilty of a class C felony;
9. Closes any records of permits to obtain concealable firearms retained by any sheriff prior to August 28, 2007 [ **closes PTA records (not destroyed), obtainable by court order only** ];
10. Removes the requirement that a person must reside in the state for a period of six months prior to applying for a concealed carry endorsement. [ **Allows someone who moves to Missouri (as a resident) to get a MO CCW Permit right away.** ]

# the GREAT VOTE

On 10 October, 1991, Pioneer Gun Club of Kansas City, Missouri voted to require all club members to simultaneously maintain NRA membership.

Over the years, unorganized attempts to take the club 100% NRA had been defeated, due not so much to active opposition to the goal, but rather, apathy. And so, in light of local and national slanders on gun owners' characters and attacks on their rights, a determined club member decided that it was time for another attempt.

The matter was introduced and brought to a vote of the membership at a regular meeting. The NRA activist had taken the precaution of notifying like-minded members on the matter of the upcoming vote. The motion for 100% NRA status was made, seconded, and passed by a slight majority; it then floundered on the rock of the club bylaws. The bylaws include qualifications for club membership. It turned out that changes to the bylaws could be made only by a two-thirds vote of the membership in attendance at the meeting at which the vote was taken, with notice of the upcoming bylaws-change vote presented to the membership via the US Mail. The exhilarating victory was nullified.

At the next meeting, the requirement to join the NRA was put in the form of an amendment to the bylaws. The proposed amendment was placed in the club bulletin, and the vote was scheduled for the October membership meeting. Partisans for and against the amendment burned up the telephone lines gathering support for their respective positions. Both parties were hampered in this electioneering by lack of access to the club's membership roster. Through long practice, only the club secretary had access to the entire membership list. The advantage in such a case goes to the side with the more gregarious partisans: those who participate in club functions and who collect phone numbers of persons met at matches and club meetings.

Opponents to 100% NRA status did so out of sincere concern over what they perceived to be potentially damaging effects such a requirement would have on the club. Arguments included such concerns that a requirement to join the NRA would alienate older members of the club who were on a fixed income; a

number of members (some of them NRA Life Members) simply did not want to be “told what to do.” And there were some members who were demanding to know what the NRA had done for them, while sitting on a range built to NRA specifications, and after discussing plans for future ranges to be built on club property.

It was considered unlikely that members would desert the only complete range in our area over the cost of NRA membership. The point was made that many members shoot the dollar equivalent of NRA membership in a single afternoon. The benefit to the club itself was a harder argument to address, and it was answered with the argument that there would be no ranges, no matches, and no club without the NRA to define and protect the sport. Opponents argued that NRA benefits were excellent reasons to join, but not sufficient reason to force people to join.

The night of the “great vote” saw more than twice as many members as usually attend membership meetings. Even so, attendance represented only 10% of the general membership. Some brief preliminaries were covered regarding a Schuetzen match and a plan for future range expansion. Then, prior to the vote, the floor was opened for comments regarding 100% NRA status. Advocates heatedly stressed the Second Amendment aspect of NRA's work. Opponents argued that NRA membership did nothing for the club. A relatively new Pioneer member rose to say the he had only heard of Schuetzen since joining the club, but did not know what it was.

“Even so, every time I re-up for NRA,

I support Schuetzen matches. It is the NRA which determines the rules, the ranges, and the rifles used in Schuetzen and all the shooting sports. The NRA is the only national organization which looks after all interests of all shooters. From range construction, to match rules, to hunting, to collecting, to the Institute for Legislative Action, the NRA is recognized as the authority. Membership in NRA supports and strengthens all the shooting sports. Without the NRA, each sport and each club would certainly hang separately. Separately, the shooting sports and shooting clubs will die; only in unity is there strength.”

“Members have argued that to require membership because of the good done by NRA could be used to justify requiring membership in other groups such as the Shriners or the PTA. This point is well taken. However, the NRA is not just another organization. It is the only organization which can be depended upon to support every aspect of the shooting sports. The NRA is carrying the future of shooting in the United States. Every shooter and collector – every gun owner – benefits by its activity. It is unfair both to the members of the club and to NRA to allow people to enjoy the benefits and opportunities given by NRA support for gun owners to not pay the piper.”

He continued, “A long time ago, I was forced to join a labor union. I did not want to. It was a summer job; I was young and had other things to spend my money on. But I thought about it and realized that my job came with benefits the union had fought for and so I decided it only fair that I pay my share. The NRA is the only group struggling to protect not only ALL of our shooting sports but our very right to keep and bear the arms with which we practice them. And so, if we want to continue enjoying the benefits of gun ownership, it's time for us shooters – ALL of us shooters – to join the union!”

The amendment passed 48 to 14.

Speaking from a prepared text, he said very much the same things that Senator Obama had previously excused, and the Senator then expressed his outrage that America was being disparaged and rejected his old pastor. It just seems to me that he had to reject the man to stop the film clips. He had already embraced the man after the old film clips, so he had to reject him for something new. I think, that by conspiracy or stupidity, the pastor was induced to make a new speech damning

America so that Senator Obama could reject him. Of course, I am told by knowledgeable persons that if a political action could be explained by conspiracy or stupidity, that I should pick stupidity every time.

There is concern that of the three leading presidential candidates, (as of this writing) none can be said to be on our side. If I were to rate them, I would say that Obama is the worst, and McCain the least worst. If this were the only rating, it would take little time; however, Obama is the worst, but Clinton knows where the levers of power can be found, and how to use them. McCain may be the least objectionable, but that is not by much, and there is a rumor that he intends to serve only a single term. He may not care what political opposition he stirs up. Still, McCain will face a Democratic congress which will oppose all his actions as a matter of policy.

It is said that voting for the lesser of two evils is still evil, and only serves to move the debate in the direction of evil. It is also said that the lesser of two evils slows the march towards evil. The theory is that, if votes are given to a third party, this will give victory to the more evil, something we are trying to prevent. Some daring spirits say that we should vote for evil in the expectation that there will be a vast revulsion against it, which we can ride to victory in the next election. This assumes much and gambles a lot. We must remember that Bill Clinton was handily re-elected and his Vice President nearly elected after him.

Of course, we can vote for a third party candidate. Some say that this will teach the major parties a lesson. We have endorsed a third party candidate for president before, the year Bill Clinton was elected. I'm not sure that the major parties notice when we do so.

This is not an easy year for political decisions. I must agree with fellow WMSA Board Member, the Learned Larry Swickard. We must turn out in droves for the election in order to vote for other candidates. We must have executive-proof legislatures and congress. We must have mayors and school district members who

are on our side. We may spend every day of the next four years as if the Second Amendment is the Alamo. The more elected persons who are on our side, the harder it will be for an executive to promote a project to hurt us. I wish I knew what to say about the presidential race, but I do not. I am told that waterboarding can fix that.

I see that the Asian Snakehead fish has been found in Arkansas. This beast is often called "Frankenfish." It has lungs and legs and so can travel over land. It has a voracious appetite, and it is feared that it will destroy American sporting fish. It is uncertain how the fish arrived in Arkansas. One story has it that a fish farm had some, was told to get rid of them, and so tossed them out on land to die. Then the air-breathing, walking fish began its odyssey. It may be that the fish paid someone to smuggle it into the country like every other illegal alien. There are proposals to stamp out the fish involving rules, regulations, and inspections. The project might go faster if American fishermen were told of an opportunity to catch a unique trophy. Militias come in all sorts.

I met a fellow who was proud of his solution to illegal immigration. He said that they should all be put into dump trucks and dumped across the border. He said that the only problem with his plan was that it was too radical. It is not. It has been done in the 1930's when Mexican workers were loaded on boxcars and dumped in Mexico. They came back. The entire project was not consistent with "well known American humanity." The quoted passage is from the German surrender demand to the garrison at Bastogne. The nazi commander threatened to destroy the town with artillery and implied that the effect on civilians would be our fault. The nazis thought that humanity was our weakness; it turned out to be a strength. An interrogator of those days told me that German soldiers were advised by their fathers to join the Infantry, be brave, get up on the front lines, and surrender to the first American they saw. They surrendered in droves. We should go with our strengths. There must be a humane solution to illegal immigration; I cannot claim that I know what it is, but there must be one.

After practicing immigration law for 25

years, the only thing I know for sure is that aliens are coming here. It is not just for the money, it is not just for “well known American humanity,” they want opportunities for themselves and their children that their own country does not provide. Many immigrants carry the belief that they must let the government do as it pleases if they are to survive. We need to make Americans of these people – and by “we,” I mean us. If we explain the Bill of Rights to a citizenship class, it will be different than if the liberals do it. If we are the image of an American citizen for them, we can make this work.

On “Cinco de Mayo,” it was reported that the day commemorates a victory of the Mexican army over the French army. Actually, it was Mexican militia over the French army. This was well after winning independence from Spain. I can recall no other country which can brag of driving out two different colonial powers. We should be able to build on this. The media will not mention militias even in this positive light.

Charlton Heston has died. I met him briefly during the Proposition B battle in 1999. It was more memorable for me than for him. Although he began as anti-gun, he came over to our side with a vengeance. He was a powerful advocate for our principles and will be missed.

In the Heller case, the Supreme Court asked a number of questions regarding the Second Amendment. They asked if there was a right to pistols, thinking they were lightly used at the time of the Bill of Rights; they asked if the right was confined only to persons in the Militia. Of course, pistols were used in the founding of this country. Any reference book on weapons of the revolution has a chapter on pistols to include pocket pistols. Militia of the time included the whole of the population. Certain parts of the population were required to have militia weapons and appear for militia drill; however, in times of emergency, even the exempt persons were expected to turn out. A party of this reserve militia served at the Concord Bridge during the opening battle of the American Revolution. When the Confederate Army attacked Gettysburg, John Burns, a veteran of the War of 1812, took up his old musket and fought. He

was wounded three times. When the Japanese occupied the Philippines, the population spontaneously formed militia groups, even when they did not have guns. Today, the U.S. Code at 10 US Code section 311 defines the organized militia, the National Guard and Reserves, and the unorganized militia, the rest of us.

Lawyers for Washington DC told the Supreme Court that militiamen did not really own their militia weapons because they couldn't pawn them. It would defeat the militia purpose if their guns were in pawn shops or seized for debt. This worked to the benefit of militiamen. In some state, it evolved into a right to exempt the family rifle from debt collectors. They also argued that a Boston law from the Revolutionary period which prohibited loaded firearms and gunpowder from being stored at ground level was the same as the DC law. The Boston law was a fire-safety law and does not evolve into a total prohibition of loaded guns anywhere in the house.

Rally Day was held on 29 April, 2008. I had planned to use the Rally to focus on the Supreme Court case. I had a recording of the arguments which I planned to play; things changed. Recordings of the arguments were widely available elsewhere. More importantly, there have been assaults on shooting ranges. A range protection bill was languishing in the legislature and needed a push. One advantage of being the absolute tyrant of a group of heavily-armed persons is that I really must listen to advice. The focus of the Rally was changed on two weeks' notice. Coincidentally, on the day of the Rally, Peter Lyskowski of the Attorney General's Office reported that Washington State has become the 35th state to recognize the Missouri License To Carry. Mr. L is in charge of reciprocity issues for the A.G's office. I do not trust these people out of principle, but I trust him. He hopes to add a couple more states. Missouri's license is the most widely recognized in the country.

Missouri ranges have been sued and hit with crippling judgments and injunctions which shut them down. One range was the target of false lead contamination complaints, and when that did not work, a structure off the range was repeatedly shot in the apparent belief that this would be blamed on the range. Investigation showed that the shots came from a spot off

the range property. I have heard of people who complained that bullets from a range landed on their property. As proof, they showed bullets they claimed to have recovered from their property, which were still loaded into cartridge cases. Some complainants lie better. All they have to do is lie, and we must spend thousands of dollars to protect safe places to shoot. That is why we need range protection.

I checked the Brady website; in their “material” about the Supreme Court case on the Second Amendment, it is clear that they are kicking Washington DC to the curb. They focus instead on how “reasonable” other restrictions might be. During the arguments, our side was questioned on what restrictions might be constitutional. The attorney said that a wide variety of restrictions might be constitutional; I would have done the same. Those restrictions were not being argued that day. Granting the possibility made it more likely the Court would rule for us. The Supreme Court has accepted a case involving the Lautenberg amendment. This law prohibits gun ownership by anyone who has ever been convicted of domestic violence, even if they were convicted before the law was enacted. This has been challenged on constitutional grounds. The Court accepts a small number of cases each year. I cannot conceive of why the Court would take a case which explores the limits of the Second Amendment unless it had decided to rule in our favor in the DC case; however, the Court can conceive of things I cannot.

There is a program on the fitness channel called “Shimmy.” It purports to teach women how to belly dance. When I ran across it (quite by accident and you cannot prove otherwise), I wondered what percentage of the audience was actually burned-out old guys. There is no obvious answer, and it will require further research.

We shall overcome.





# THE SECRETARY'S NOTEBOOK

## MINUTES\* – MSSA Board of Directors Meeting

April 26, 2008

\*Tentative, subject to Board approval.

The meeting was called to order by President Kevin Jamison at noon. Board members in attendance included Kevin Jamison, Grace Leinberger, Lee Koester, Mona Oliver, Tim Oliver, Zac Bauer, Larry Crawford, Stu Strickler, and Terry Brookman; absent were John Leinberger, John Teachey, Harold Miederhoff, Greg Jeffery, Sheila Stokes-Begley, David Jones, Greg Meredith, Michael Meyer, Terry Struse, and Roscoe Morris. The reading of minutes was waived; a motion to accept the minutes of the last meeting as printed in The Missouri Shooter was seconded and passed.

### BOARD REPORTS

*Treasurer's Report:* Lee provided a written copy of the financial report covering the last five months. The current checking account balance was \$19,443.79. Income over the last five months was \$12,282; expenses, \$5,769.73. The general fund included undistributed monies targeted for Junior Programs. An account had been set up for the Junior Highpower program under John Teachey; starting balance, \$2000. The M-1 Raffle brought in about \$2200 after expenses; Lee wanted to get this year's raffle started early to bring in more money for the Juniors Programs, especially for the camps and the new junior high power program; he also wanted to hold silent auctions at the annual awards dinner for the same purpose. Lee reported that the Juniors Committee had decided to hold distribution of junior funds until a junior program needed it, with the remainder of the funds to be distributed between the two Junior accounts evenly at the end of the year. A motion was made to accept the Treasurer's Report, which was seconded and then passed.

*Juniors Report:* Grace provided a brief report on behalf of John L. and John T. The two smallbore junior camps to be held in June and July were still planned, and a number of kids were already registered. Grace also relayed an invitation from John Leinberger to all the members of the Board, that they were welcome to come to the camps and observe; the invitation was well received and appreciated by the members present.

*Newsletter:* Kevin reported that Sheila had to resign as newsletter editor due to pressures of other responsibilities; Kevin asked if Mona would be willing to take the position; she advised she was, at which point the Board appointed her to the position. (A discussion followed regarding the oppressive zoning restrictions in the rural county where Sheila resides, which led to a discussion on abusive zoning and the potential impact such might also have on ranges.) Mona reminded Board members that the newsletter deadline was on May 1, the first day of the month immediately following a quarterly meeting, and to start work on articles.

*Website:* Zac advised that he and Mona were making some changes to the website; Mona had updated the front page with Rally information; Zac would also be removing the "business partners" link and webpage, as MSSA had no business partners [this page is assumed to have once been advertiser info, but had long since fallen by the wayside]; the link is to be replaced with the link to the Affiliates page; Zac requested an updated list of affiliates. Zac also requested pdf's of the more recent newsletters; Mona advised she had new web-optimized newsletter pdf's ready and would upload them to the site, and would be renaming all TMS files to reflect the volume/issue rather than year/month. [Note: the newsletter volume reflects the year.] Lee requested a few changes to the online membership application, Zac advised he would implement those changes.

*Treasurer's Report, addendum:* Lee advised the current CD (worth \$5883.52) was going to come due in or around June. Lee then made a motion to take \$5000 out of the general fund and add it to the CD at that time to generate more return on the interest. The motion was seconded; there was no discussion when called; on voting, the motion was passed. Lee also reported that the MSSA financial paperwork and taxes were done.

*Membership Report:* Lee advised there were 866 current paid members; of those, there were 668 standard adult members, plus 7 beneficiary life, 4 honorary life, 140 standard life, and 44 junior members. Lee reported a gain in life memberships, but that 4 life members had also died in the past

year. There were 33 paid affiliates, excluding those who were expected to renew but still had not yet done so; some Board members advised they would make personal contact with certain clubs about their status. Lee inquired after Lindenwood University which had not renewed; a discussion followed. Lee reported he had found a listing of all fifty state associations for the Comp database and would be contacting them for a mutual exchange of publications, the newsletters to go to the Secretary.

### OLD BUSINESS

Kevin reported on the pending tax exemption status; still plodding along, and the IRS had sent more paperwork. Zac made changes to the new draft MSSA brochure and replaced some pictures; he then passed out an example to the Board for review; the cost for printing a thousand high-quality color glossy brochures, pre-folded, would run about \$200 to \$225, plus shipping; discussion followed on what pictures should be included and the number of brochure needed; Lee made a motion that 1000 of the new brochures just reviewed be produced to have on hand now and that two alternate brochures also be designed; discussion followed, then the motion was seconded and passed. There was discussion on putting a "Shooter Spotlight" section on the website, highlighting top competitors. Mona advised that Michael Meyer was still not subscribed to the Board's group mailing list; she would continue to work to get him on it. The Board then took a short break. After the Board reconvened, Kevin announced there would be a shooting sports summit, June 23-25 in Colorado Springs, CO, and had a web address for more information ([www.nssf.org](http://www.nssf.org)). Tim then provided a detailed report on the noise nuisance lawsuit against Cedar Creek Rod and Gun Club, followed by a report on legislative issues; there was discussion on both matters. The Board then discussed plans regarding the Annual Gun Rights Rally.

### NEW BUSINESS

Zac inquired on the status regarding a recommendation he made a couple of months ago to the Juniors Committee to donate \$250 to the Wildlife Clinic at Missouri Outback Wilderness Lodge; Lee responded that the Juniors Committee was still developing criteria for outgoing donations, and added that he had also been in contact with Johnny Everhart; discussion followed on the availability of general funds (most of the money in the fund covers the cost of printing/ mailing the quarterly newsletter), the funding of the new junior program; discussion included feedback on the funding of outside programs; the Juniors Committee decides outgoing donations for youth programs as the money comes out of the junior funds. The Board then discussed a donation to the Owensville Gun Club's M1's for Vets Project. Tim then advised he had been asked to volunteer to do the air gun shooting program during a 2-day Cub Scout day camp in Columbia for 6-10 year olds; he accepted, but advised that he needed one other person to help each day (8 hours, June 4<sup>th</sup> and 5<sup>th</sup>); Grace responded that she would get with John about finding him help. Lee had several items: The contribution to the Conservation Federation of Missouri was coming up and the Board needed to decide on continuing affiliation, the Board decided to continue to do so; Lee advised the NRA contacted him any time a new gun club opened up in MO and that he would then send a letter and complimentary newsletter to the new club inviting them to join MSSA; Lee next passed out a list of Board members' contact information, which the members present were to update and return; he then read a nice letter MSSA had received from Warren Loschky, the winner of the M1 Raffle; Lee advised he was in the process of reworking membership cards with Mona's help, with separate styled cards for different member types (standard adult, junior, and life) and requested color suggestions for the cards; Lee then reported on the MDC Annual Outdoors Adventures Expo at the Busch Shooting Range and Outdoor Education Center set for July 26, that MSSA would get a free table if we wanted it; Zac volunteered to work the Expo, as did Stu.

A motion to adjourn was then seconded and passed, and the meeting was concluded at approximately 2:30 p.m.
