STATUS SPRING 2011

The NRA Convention will return to St. Louis this spring on 13 through 15 April 2012. The last time the NRA came to St. Louis the turnout was enormous. I kept hearing a bell ringing and found that every time a life membership was sold the bell was rung. The bell rang and rang and rang. The convention had been moved to St. Louis on short notice when the previously selected city adopted an anti-gun ordinance. MSSA stepped up to help and contributed to the convention's success. Concealed carry is banned in the St. Louis convention center, which only shows that we have work yet to do.

The MSSA annual dinner and meeting will also be in April, on the 28th in the DAV hall in Jefferson City. The meeting has been moved to April to avoid the white fluffy global warming we had been threatened with during the winter months. We expect to have the door prizes we have enjoyed in the past. Awards for our outstanding shooters will be presented.

Rally Day will be held on 18 April, 2012 in Jefferson City. April has become a very busy month. Every year we hold Rally Day in order to promote bills we like and oppose bills that we dislike. In the absence of such bills we remind the legislators that there are a great many of us and not only do we vote, we come out and encourage others to vote.

The Board has been informed that some veteran's homes have banned gun possession by the veterans. These are not homes for the senile or otherwise mentally deficient. These are communities for men, and increasingly women, who have retired. I have seen other proposals that elderly people be disarmed. Some organizations that assist elderly persons with independent living will not assist people who have guns in the home. This is a perfect gun for kids since it is small, no scope to hit them in the face, and easy to use since it has the short-adjustable stock, a forward grip, and minimal recoil. She used 64gr Moly-Coated PowerPoints in .223. She shot it at 40 yards. - Ryan

Magazine Buck

I have a term for bucks like the one that could have caused my death many years ago: magazine buck, like when we drool over the glossy page of some outdoors magazine as we study the details of the Christmas tree rack under the grinning visage of the fortunate hunter. He was like that, my magazine buck. I think of him often, think of the moment when our eyes met for the only time in that instant just before he zipped to the east and I zipped to the south, as in “down”.

I had been in the tree stand, eighteen feet high, for two hours and dusk was settling in around me, the woods transformed into a comprehensive shadow in seemingly a matter of moments. It was time to leave. I hooked my



bow to the line, lowered it to the ground. I swept my vision one last time toward the field's edge and it was then that two indistinct forms took shape seventy-five yards distant. I froze, squinted into the gloaming, saw movement toward the field. The first buck was a yearling, and he entered the field with the recklessness of whitetail youth. The second buck, full-bodied and tall, carried a very good rack, probably eight points; it was too dark to count. He eased into the fading light only after watching the yearling for a full two minutes. Then a great form that I had not detected materialized, and I sucked in a shallow breath as I locked in on it. Another couple of minutes oozed by—sand stuck in the hourglass. Finally assured by the lesser bucks that there was no danger, my magazine boy eased into the field. He cranked his neck directly away from me and could clearly detect that the typical rack width was a half foot beyond the points of his ears, symmetrical, tall tines, stunning. I don't remember what came out of my mouth in the little spurt of a whisper that escaped me, but no matter, it was likely unprintable. It didn't matter that my bow was on the ground; it was too late to take a shot and there was little possibility that he would retreat from the field. All that mattered was my ability to slip from the tree and out of the woods without disturbing him. A simple thing.

The first step from the stand was left boot on a four-inch limb, the remaining steps were metal, screw-in. As my boot found the familiar limb I took a final glance toward the buck. I have no clear memory of making a sound, but the great head and rack jerked toward me, followed by a woofing snort that could have passed for a wounded buffalo, and then all three bucks evaporated as if erased by unseen powers. A second later, three things happened within a fraction of the ensuing second: I was in free fall, I clamped the bear hug of my life around the twenty-inch hickory, and I jerked to a halt. The latter happening was joyous until the pain registered in my crotch, at which locality I was impaled on a metal step. I have no memory whatsoever about just how I managed to become un-impaled, but I can report that tiny bark shards were later detected under three fingernails, two of which were mangled to some degree. Nor do I have any memory whatsoever of climbing the remaining four steps to the ground. When my heart rate receded to low triple figures, I slumped to the grass and took stock of the sad situation: absolutely no person on earth knew where I was, I carried no cell phone, and I was a half-mile from my truck. On these facts I did not dwell, nor did I dare to look at my wound, now seeping blood down my leg. Idiotically (at least it seems so as I write this) I unhooked my bow, clasped it in my right hand, and began the long trudge. I hummed tunes, trained my thoughts on pleasantries past as best I could. Right boot forward, left boot

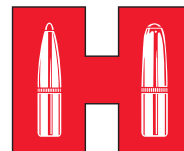

forward, steady pace, listen to the tunes blend with the swishing of the long grass, until I finally spy my truck. A year later, after I made a bad shot and stuck a broad head in a tree, a buddy who was two hundred yards away at the time, and to whom I confessed the errant shot, later went back to the tree and found the broad head, sawed it from the tree, and presented it to me with a guffaw. To this tree chunk is stapled a section of my skivvies, complete with dark blood stains surrounding a hole. It resides on my office desk. I have told the story often to all who enter the deer woods.

May you all see your magazine deer one day. When you do, be careful.

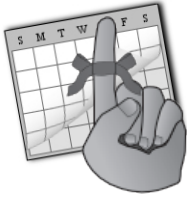

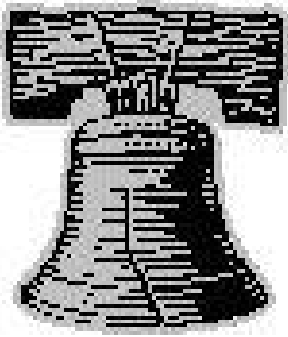
Hoi polloi Not Invited By Zac Bauer (Editors opinion)

It is a good day for Liberty.

State Smallbore Championships

The second and fourth weekends of September saw SB shooters gather at Bucksnot Range for the 2011 State Championships. The weather was fantastic with mild temperatures and very little wind condition. The shooting was dominated by Missouri's own (and MSSA member) Garrett Spurgeon(17), a high school senior from Canton. He just happens to be the current national Intermediate junior champion, national junior champion, national civilian champion, and national championship runner up for 3-position. He has also signed a national letter of intent to take his shooting talent to West Virginia, a perennial national shooting power.

Garrett started the prone championship off with an outstanding iron sight score of 1598-115X. He followed up the next day with an any sight score of 1599-141X for an aggregate of 3197-256X. That was 7 points better than the nearest competitor and set a range record for the 3200 aggregate. In the any sight aggregate, seven of eighteen competitors shot a 1595 or better including a perfect 1600 shot by Mike Barron from St. Louis. The special 200 yard match was won by Harold Miederhoff from Columbia with a decent score of 198-9X. This is shot using the pit operated targets and is really a fun competition.

An interesting side note to the competition was a tie of 400-39X in the 50 yard any sight. The tie breaking rules say to look at the targets in reverse order of shooting. They came up identical, that is, the non-X was on the same bull. The rules say to count center shots meaning inside the X-ring. Scorers worked over the targets and found the same number of center shots for both competitors. The reverse order was applied again and a winner determined, finally. In many years of competing in SB tournaments with less than 30 competitors, this is a first for the author.

In the 3-position championship two weeks later, Garrett showed that he has promise to be a star on the national scene. He won all six fired matches and the three aggregates to again dominate the firing line. We will miss Garrett at many of our competitions in the mid-west as he goes in pursuit of higher education. We wish him the best and hope to see him do well at the college level of shooting.
