The President's Rodium

It has been a memorable year for the shooting community. The Supreme Court ruled that local government must respect our Second Amendment rights. At almost the same time certain judges ruled to restrict those rights. A judge in Westchester county New York is signing "no knock" search warrants to discover if licensed gun owners are storing their guns safely.

Two new cases create trouble when transporting guns across state lines. Federal law under 18 U.S.Code §926A states that guns can be transported through any state, regardless of that state's law if it is unloaded

and in a locked container, inaccessible and can be possessed in the states of departure and destination. On 22 March, 2010 Gregg C. Revell v Port Authority of New York was handed down in the Third US Circuit followed on 30 June, 2010 by John Torraco v Port Authority of New York in the Second US Circuit court of appeals. They both involved persons who were traveling by air through New York and New Jersey. Each checked his gun at the airport counter under Transport Security Administration regulations, each was arrested and the gun seized. The various plaintiffs sued under 42 U.S. Code §1983. Under that section persons can sue government officials and agencies for violations of federal rights. It appears that §926A is not a federal right; it is at best a defense to criminal charges. Many of these defendants were in New York and New Jersey because their flights had been diverted or delayed. I believe that Torraco was the case where a Port Authority Police Officer proclaimed, "This is New York City, federal law does not apply!" This view of federalism was rejected by a decision at Appomattox courthouse in 1865.

The moral of these cases is that if one checks a firearm with an airline it is imperative not to touch the gun until at the destination. If the aircraft is diverted to another state under no circumstances can the traveler touch the bag holding the firearm. Insist that the airline secure the bag.

In 2008 the Missouri legislature, in its nearly infinite wisdom, changed RSMo 571.070 which bars gun ownership by convicted persons. The new language prohibits possession by convicted persons (but not those who pled guilty). This appeared to bring it in line with the federal statute but it failed to specifically exempt persons who have received pardons, expungements, restoration of rights or a Suspended Imposition of Sentence. It seems that pardons, expungements, restorations of rights or Suspended Impositions of Sentence would have no purpose if the statute applied to those cases. The BATF sees it differently. Recently they have claimed that the Missouri Attorney General sees this statute as affecting persons who have had their records wiped clean. The result is that persons who have ancient, long expunged convictions are suddenly told that they cannot possess firearms or work in the firearms industry. This is wrong on many levels. Rights have been restored to people, and then snatched away without cause. The truly offensive element is that the statute does not have to be interpreted in this fashion. It has always been the law that expungements and pardons and the like have erased convictions. The new statute does not have to be interpreted as requiring a repetition of this principle. In short gun owners who did something stupid a generation ago and went to the trouble of having it removed from their records are being abused by the same system which proclaims that we have a constitutional right to own guns. The question is what to do.

To help resolve this question everyone should contact their state senator and legislator and have them request that the Attorney General answer the question; "Does 571.070 prohibit firearms possession by any person who has received a pardon, restoration of rights, expungement or suspended imposition of sentence?"

A 2010 amendment to the statute allows persons with felony records to possess replica antique muzzle-loaders. This does not include the "in-line" muzzleloaders, only replicas of antiques. Other states do not allow ex-felons to possess muzzle-loaders at all.

The Department of Conservation has decided to introduce elk into the Ozarks. This angers farmers and endangers drivers but may someday give us a chance for a weekend elk hunt.

Missouri Carry has merged into MSSA, carrying with it a number of members and network of contacts on its web site. This will help promote MSSA to a broader group.

Our Zac Bauer has improved our web site to be of greater service to members and to attract new members.

We have lost Roscoe Morris, a member and Board Member for as long as anyone can remember. When he was no longer able to shoot his greatest joy was to associate with shooters.

Writing this between the twin terrors of Halloween and Election Day I consider the most terrifying news I have received. I am emphatically reminded that John Leinberger is 72 and cannot continue running Junior Activities indefinitely. Anyone who wants to mentor young shooters while learning from the Master, please call my office (816) 455-2669.

As always, I thank-you for the honor of being your president.



Introducing the

A new hunting method has been introduced to residents of Missouri thanks to the Missouri Department of Conservation and a number of hunting enuthusiast who prefer a different kind of tool to bring down their quarry.

This is their story.

Part I

MDC Commissioner Chip McGeehan - The picture was taken in 2010 when several Missouri Atlatl Association members met with Commissioners and MDC staff to demonstrate the atlatl.



Starting in fall 2010, hunters will have the opportunity to pursue deer with an atlatl. While this is the most recent hunting tool to be recognized by the Missouri Department of Conservation, it predates the bow and arrow by a thousand years. In the Americas, for example, there is evidence that the atlatl (pronounced at-la-tel) was in use thousands of years ago. Often considered the first compound weapon because it consists of two parts - the atlatl and the "dart" or "spear," - it provided early hunters the ability to bring down large game, including mammoths and mastodons, from a longer distance than was possible with hand held spears.

The term "atlatl" is from the Aztec language of Mexico and has generally been adopted today by modern enthusiasts in America and elsewhere in place of the more generalized name of "spear thrower."

In the Americas it was the primary hunting weapon for thousands of years, and while the bow and arrow started to replace it about two thousand years ago, it continued to be used by some cultures up to modern days. In fact, it is still used by a few Inuit people for hunting seals and is also used by some aboriginal groups in Australia.

The atlatl is a deceptively simple device. Typically, it is a narrow piece of wood about 22-24 inches in length with a handle on one end and a "spur" on the other end. The spur can be carved into the wood itself or can be made from a separate material such as antler or bone. The spur of the atlatl engages the dart which typically has a "dimple" or small indentation at the back end. Darts can vary considerably in length, but typical darts used by modern atlatlists

are about seven feet long. They can be made from a variety of natural materials or man-made materials. One of the most popular dart materials is river cane (native bamboo) which grows in parts of Missouri and is widespread throughout the southeastern United States. It is durable, and is naturally tapered which allows for more flex toward the back of the dart. Various reeds, wood, as well as aluminum and carbon can be effective dart materials. While not necessary, most darts are fletched.

The dart is propelled by a motion, somewhat similar to throwing a baseball. The key to obtaining maximum velocity is the rapid rotation of the wrist. With the arm bent at the elbow and at a right angle to the body, the atlatl is brought quickly forward in a throwing motion. Near the end of the throw, the wrist is rapidly rotated. The faster the wrist is rotated, the more force is transferred to the dart. (Note: You can see demonstrations of throwing on You Tube or by going to the World Atlatl Association's web site: www. worldatlatl.org.)



Modern interest in the atlatl began to grow with the founding of the World Atlatl Association in 1986. Today, there are numerous target competitions throughout the United States and in a number of European countries. While many atlatlists have limited their interests to target events, others have also been working to promote the recognition of the atlatl as a legitimate hunting device.

The Missouri Atlatl Association's (MAA) efforts to legalize the atlatl started in 2003 when we first met with the Department of Conservation Department's Regulations Committee. As a result of this meeting, they suggested we work with the Conservation Federation of Missouri (CFM) in order for them to recommend action to the Department. Over the next several years, we gave demonstrations to and made presentations at the CFM annual meetings. In 2006 we introduced separate resolutions to legalize the atlatl for small game and for deer. In response, the CFM Resolution Committee recommended to the Department to legalize the atlatl for small game immediately and to actively study the possibility of legalizing it for deer. As a result, the atlatl was legalized for small game beginning in spring 2007. In early 2010 several MAA members met with the Regulations Committee. As a result of that meeting, the Department decided to legalize the atlatl for deer during this firearms season. Although, we believe it is most appropriate to include the atlatl during archery season and hope the change will be made for 2011, the MAA greatly appreciates the significant step that the Department has taken. We feel that because of the Department's national reputation for excellence, their decision will have a positive impact on legalization efforts in other states.

TALES FROM THE HUNT

"Just Me and Duke" By Gary Miers

For the most part, I get to hunt every day during duck season, and I figure I owe some thanks to God for that. I don't hunt on Sunday mornings. On Sundays, I go to church and worship God in the morning, then I hunt in the afternoon until sunset... and usually have time to make it to Sunday evening services too.... and for the most part... folks have gotten used to seeing me at church in my camouflage on Sunday evenings.

This past season, we had a lot of unseasonably warm weather, all the way up to the beginning of December. Early in the month, one Sunday afternoon, for whatever reason, I didn't manage to get to the club until around 3:00pm... By the time we get out of church, go out to eat somewhere, and get back home, it can easily be 2pm... but shooting

time doesn't usually end until around 4:45 or so... so if I get to the club by 3, I still have almost 2 hours to hunt. On this particular Sunday, when I got to the club there were only 3 trucks there, so I figured I'd be joining 3 or 4 guys in one of the blinds... which is a typical occurrence.... However, much to my surprise, when I got inside the trailer, the board showed there were already 5 guys and 2 dogs in the blind... some of the guys truck-pooled? That almost never happens... oh well... they were all in blind # 2.

One thing about duck hunting is that wind has a lot to do with how ducks will want to approach their landing. Therefore, wind direction has a lot to do with blind selection.

At the club, blind #2 faces mostly south but is turned slightly to the west and can be a good blind on a calm day or when there's a north wind... the ducks land right in your face... apparently there WAS a north wind earlier when those guys arrived... but by the time I had arrived the wind had shifted out of the west... which is fine... the ducks will land in on blind 2 from left to right....

However, blind 3 faces east... and with a west wind... you guessed it... the ducks land right in your face... So... since blind 2 was full, I put on my waders, grabbed my gun and got Duke out of the truck and we headed for blind 3. I have all of the guy's cell phone numbers so I called one of the guys and asked them how they'd been doing so far. Ed said they had been there since noon, and only had 5 birds, so it really wasn't looking very promising... I hadn't killed a bird since Tuesday... but with the strong wind, my hopes were high.

I had just got in the blind and barely had time to get my gun loaded, and noticed I had a mallard hen, locked and committed, coming right at the blind. I pulled up and dropped her on the first shot, about 15 yards out in front of the blind, but it wasn't dead. Duke jumped out after it pretty quick, but before he could get on the bird, it started diving under. Not a big deal usually, he stays on them, and he will dive under after them if necessary. However, this was one smart bird... it was swimming away underwater, and came up about 10 yards to Duke's left... and Duke chased toward it... and it dove under again... this bird was not going to give up easy... next it popped up about 10 yards to his right... I jumped out of the back of the blind and went around front to give Duke an assist.... the bird kept diving and circling back... finally it popped up near the edge of the corn, and I was between the bird and Duke so I finished it off with another shell. Duke fetched it up and we headed back to the blind.

The wind was blowing hard...and a lot of birds were flying around everywhere... amazingly, I could not hear the duck calls of the guys in blind 2. Normally on a less windy day, you can easily hear the calls from the other blinds in the club... sometimes you can hear the calls from the adjoining duck clubs.

We hadn't been back in the blind only for a few minutes when a pair of mallards started working their way in... I called and they circled around twice... but with that strong wind, they hung up just out of my range... then finally they turned over blind 2... I saw the guns come up... and I think all 5 of them boys unloaded their guns... all misses... no birds...

Not long after they shot, another pair of mallards came in from the north, crossed in front of me before I could get my gun up and almost landed about 10 yards south of the blind... of course I was on the north end of the blind, so when I did shoot, the shot seemed a little far... the hen was closer, and the drake was out of range... I pulled up and dropped the hen. Duke ran out and brought her back no problem... that bird was dead before it hit the water.

Now... I have 2 hens... and for a duck hunter, this is a bad situation... in Missouri, the daily limit is 6 ducks... of



which you can only have 4 mallards, and only 2 of those can be hens.... Normally I do try to only shoot the drakes, but this season, we seemed to have an excess of hens, and a shortage of drakes. From this point on, I'd have to be selective and only shoot greenheads.

Finally, after a bit of what seemed like calling at birds with no response, I had a pair working in... but they hung up over blind 2... swung in on them... they shot and dropped both... although I could tell one wasn't hit too well. They shot several times at it on the water, then I saw one of them get out of the blind to go chase it... later, after the hunt they said when they shot at that duck on the water... they aimed directly at the bird and they could see their shot spray the water about 10 yards to the left of the bird. Now that's a strong wind!

There were a lot of birds flying around, but for some reason, they didn't seem too interested in my calls or the decoy spread.

Finally, after what seemed like a long time since Duke had retrieved that hen, I finally had another single working straight into the blind... but it hung up at the edge of the hole, just out of range... that wind blowing from directly behind the blind... I called again, and it came around... I was having trouble making sure it was a drake, but once it got close enough... bang... I dropped that butterball right in the decoys.... Duke was like a laser beam on that bird, and brought it back picture perfect. Now, I had 3 mallards, and I can only take one more greenhead or some other bonus duck... and it seemed there were only mallards flying this afternoon, but you never know what might drop in on you.

I think with the strong wind, the most of the ducks probably weren't able to hear my calls very well, except those in the direction of the wind...so I stepped up the volume to try to get their attention... And of course, this is how things happen when you're hunting by yourself... out of the corner of my eye, I noticed a bird off to my left. Before I could call or get my gun ready a mallard drake had landed just on the outside of the north end of the decoy spread. My dearly departed dad taught me a lot about hunting in general, and while it's not illegal to shoot a bird sitting on the water, I was taught it really wasn't very sportsman like to do that. Bottom line, I won't shoot a duck sitting on the water.... So, being the good sportsman... I raised my gun and was on the ready... finally he saw me sticking out of the blind, or realized those decoys weren't real birds, and jumped up... bang... I knocked it down...but dog gone... it wasn't dead... it was trying to get up. I fired a second shot and missed, but Duke had an eye on it and I could tell he was on it. He chased it down and got it... and of course, brought it back to the blind. So... I had my limit of mallards... and was thinking I might get an opportunity at a bonus duck... or two... but with a check of my watch... Wow...it was only 5 minutes until shooting time was over.... Man that time flew by... So, just me and duke in the blind... we managed to get our limit of mallards, and had a ton of action. Even though I only fired 6 shots, it was one of the most memorable hunts of the season... just me and Duke.

Noting its popularity WMSA President-for-Life SHEILA has ordered that all future WMSA meetings be in 3-D.

For those of you who believe that the Supreme Court decisions in Heller and MacDonald mean that we won a final victory, a judge in Westchester county New York is signing "no knock" search warrants to discover if licensed gun owners are storing their guns safely.

Two new cases create trouble when transporting guns across state lines. Federal law under 18 U.S.Code §926A states that guns can be transported through any state, regardless of that state's law if it is unloaded and in a locked container, inaccessible and can be possessed in the states of departure and destination. On 22 March, 2010 Gregg C. Revell v Port Authority of New York was handed down in the Third US Circuit followed on 30 June, 2010 by John Torraco v Port Authority of New York in the Second US Circuit court of appeals. They both involved persons who were traveling by air through New York and New Jersey. Each checked his gun at the airport counter under Transport Security Administration regulations, each was arrested and the gun seized. The various plaintiffs sued under 42 U.S. Code §1983. Under that section persons can sue government officials and agencies for violations of federal rights. It appears that §926A is not a federal right; it is at best a defense to criminal charges. I remember when §926A was passed in 1986 as the "Firearm Owner Protection Act." It seems that some of our eastern judicial appointees have decided to

re-name the statute. Many of these defendants were in New York and New Jersey because their flights had been diverted or delayed. I believe that Torraco was the case where a Port Authority Police Officer proclaimed, "This is New York City, federal law does not apply!" I ridiculed this comment in an article for "Concealed Carry Magazine." Now it appears that he was right. The criminal charges against the parties were dismissed, but their property was held for years. They were forced to go to jail, pay a bail bond, appear in court and suffer the disruption of their travel plans. I cannot imagine the seizure of any other class of property, much less the arrest of the owner, that would result is two appellate courts treating the abuse as such a trivial matter. These cases were written before the City of Chicago case was decided, but do not mention Heller or the fact that such a decision was pending. We obviously have much more litigation to fight.

Chicago is forced to allow handgun ownership, but the owner must jump through a multitude of licensing, medical and marksmanship tests. It costs \$550 for these requirements to get a license to own a handgun. You buy a gun for yourself, and one for the city. The city requires a marksmanship test, but refuses to allow ranges in the city. We have won recognition of the right to own handguns, but they think that these Jim Crow restrictions will beat us. They are wrong.

Judges who hear these cases are the low profile acts of the administration. These are lawyers who know a senator who puts their name into consideration for a federal judgeship. The administration may not be able to get gun control through congress, but it can appoint judges who find that Jim Crow restrictions are "reasonable." These life appointments must be taken into consideration when we are deciding which candidate is better for us.

The Republic of Korea wants to sell their surplus M-1 rifles and M-1 carbines. American importers want to buy them. Our State Department blocked the deal on the grounds that they might fall into the wrong hands. The wrong hands already have guns. These sixty-year-old guns are valued by collectors and recreational shooters. The Secretary of State, another presidential appointee, thinks that we are the wrong hands.

In 2008 the Missouri legislature, in its nearly infinite wisdom, changed RSMo 571.070 which bars gun ownership by convicted persons. The new language prohibits possession by convicted persons (but not those who pled guilty). This appeared to bring it in line with the federal statute but it failed to exempt persons who have received pardons, expungements, restoration of rights or a Suspended Imposition of Sentence. We did not catch this omission at the time, I did not catch the omission. It seems that pardons, expungements, restoration of rights or Suspended Imposition of Sentence would have no purpose if the statute applied to them. The BATF sees it differently. They claim that the Missouri Attorney General sees this statute as affecting persons who have had their records wiped clean. The result is that persons who have ancient, long expunged convictions are suddenly told that they cannot possess firearms or work in the firearms industry. This is wrong on many levels. Rights have been restored to people, and then snatched away without cause. The truly offensive element is that the statute does not have to be interpreted in this fashion. It has always been the law that expungements and pardons and the like have erased convictions. The new statute does not have to be interpreted as requiring a repetition of this principle. In short gun owners who did something stupid a generation ago and went to the trouble of having it removed from their records are being abused by the same system which proclaims that we have a constitutional right to own guns. The question is what to do.

The Missouri Attorney General's office has not publicly announced their interpretation of RSMo 571.070. If forced to do so they will have to justify this interpretation, they cannot. The course of action I recommend is to get them to issue an Attorney General's Opinion on this point. They will not do so at the request of a citizen. They must do so at the request of a legislator. They may take their sweet time doing so, but they must do so. If a number of legislators make the same request the matter becomes a higher priority. Efforts to make this interpretation official may irritate the legislature which will aid efforts to amend the statute.

To help resolve this question everyone should contact their state senator and legislator and have them request that the Attorney General answer the question; "Does 571.070 prohibit firearms possession by any person who has received a pardon, restoration of rights, expungement or suspended imposition of sentence?"

We shall overcome.

Missouri 4-H Shooters VICTORY

Missouri 4-H shooters traveled to Texas for the 4-H Shooting Sports National Invitational – our national competition. We did great with all 9 teams finishing in the top 5 (a first). And we knocked off Texas by winning the state sweepstakes award. An award that Texas sponsors and has always won...until this year.

Missouri 4-H Shooters Top National Competition

Missouri 4-H members packed their bags, bows, and firearms and traveled to the 4-H Shooting Sports National Invitational and returned with lots of shiny hardware, including the Tom Davison trophy in recognition of compiling the top results by a state program. Since its inception, the traveling trophy had been awarded only to Texas 4-H. After eight years, that changed at 12:02 a.m. July 2 when Missouri was announced at the top program at the 2010 competition.

Missouri took a full complement of teams, 9 teams of 4 youth each plus a volunteer coach for each team. Teams and individuals compete in 3 events within their shooting discipline and are recognized for their performance in each event. Shooters and teams are then recognized for the overall performance in all three events. Missouri teams placed in the top 5 overall in all nine disciplines. These are: Shotgun, Smallbore Rifle, Smallbore Pistol, Air Rifle, Air Pistol, Muzzleloading, Compound Archery, Recurve Archery and Hunting Skills.

The 4-H Shooting Sports National Invitational took place in Kerrville, Texas June 28-July 2. Thirty-one states were represented by 516 youth at the national competition. Hurricane Alex made for wet and miserable shooting conditions most days, but Missouri 4-H shooters made the most of it and shot well.

Shooting Sports is the largest 4-H project Missouri. It has been one of the fastest growing programs nationally over the last 15 years with more than 150,000 boys and girls learning life skills as well as shooting skills under the guidance of caring adult volunteers. Shooting Sports, all 4-H programs are part of the University of Missouri Extension program.


